

RULES AND REGULATIONS
APPLICATION FOR SPP AWARDS AND HON. DISTINCTIONS

According to the Society's Constitution **3.6 & 3.7**, in order to raise the standard of photography of our members and also to promote the art of photographic research, the Society has established the following titles for those members who have achieved a certain standard in the art of photography, namely Associateship of SPP and Fellowship of SPP.

1. **AWARDS :**

- I. The above mentioned titles (ASPP, FSPP) will only be awarded to members of SPP.
- II. Any valid member of SPP or its alliance clubs is entitled to apply for the examination of the Distinctions Awards.
- III. All applicants who have successfully conferred Associateship or Fellowship must apply for life membership within a month. Otherwise, the Award will be withdrawn.
- IV. When a member chooses to withdraw his/her membership OR is expelled by the accordance with Rule 6 of the Constitution, his/her title (ASPP, FSPP) will also be withdrawn automatically. However, this clause does not cover or affect those holders of 'Honorary Distinctions'.

2. **MINIMUM REQUIREMENTS FOR APPLICATION :**

- i. **ASPP** –
 - a. The candidate for this award must submit either **15** copies of Monochrome or Colour Prints, sizes **12" x 16"** to **16" x 20"** OR **20 copies** of Digital Images.
 - b. The photographs/digital images submitted must include at least **8** different aspects of photography such as Portraiture, Scenery, Night-Scene, Nature, Close-Up, Still-Life, Sports Architecture etc. The candidate is allowed a free choice of subjects as long as they depict the various photographic technique.
- ii. **FSPP** –
 - a. Whoever has the ARPS can now apply straight for Fellowship of SPP, the application form must bear The Society President or Secretary's signature certifying their membership status.
 - b. To submit either **20** copies of Monochrome or Colour Prints, sizes **12" x 16"** to **16" x 20"** OR the submission of **25** copies Digital Images and must be ONE section from the following categories:
 - i. Pictorial Photography
 - ii. Nature
 - iii. Photo Journalism
 - iv. Contemporary Art
 - v. Advertising
 - vi. Architectural
 - vii. Medical or other Specialised Field
 - c. If the candidate can write an article which illustrates the technical know-how or creativity in photography, credits will be given to such thesis.

Specifications for Digital images

1. The image file must be in RGB mode and in sRGB colour space. **2.** The image size must be larger than 3000 pixels wide and 2000 pixels high with one dimension (width or height). **3.** The file size must be 3 mega pixels and above. **4.** The files should be named and numbered (in 2 digits form) with the author's initial (in block letters) in front of the file name followed by the distinction category. For example, Title-ASPP-01 / Title-FSPP-01. (Important: Images will be viewed in the sequence following the image numbers submitted for judging.) **5.** All images must be rotated as intended to be viewed. **6.** All images must be burnt into a non-returnable CD-ROM together with a text file containing your name and address. You may also include an explanatory note of the themes of your submission in the CD, though it is not mandatory. **7.** The submitted CD should be clearly labeled "Evidence for application of ASPP / FSPP" with your name and address on the CD and sleeve.

iii. Applicants for **ASPP** and **FSPP** should make a payment of **RM100.00**. Foreign applicants should remit **USD\$100.00**

iv. The closing date for entries will be on either **30th June or 31st December** of each year and the results will be made known before **April** of each year.

3. HONORARY DISTINCTIONS

HON. SPP	-	HON. MEMBER OF SOCIETY OF PHOTOGRAPHERS PENANG
HON. FSPP	-	HON. FELLOWSHIP OF SOCIETY OF PHOTOGRAPHERS PENANG
HON. ESPP	-	HON. EXHIBITOR OF SOCIETY OF PHOTOGRAPHERS PENANG

(The awards of these distinctions are not open to application)

A person (non-member) or member of SPP who has achieved or has been actively involved in promoting photography directly or indirectly at national or international level will be eligible for one of the following awards.

- i. **HON. SPP** – The candidate must be actively involved in promoting photography directly or indirectly international level.
- ii. **HON. FSPP** – The candidate who has achieved one of the following:-
 - a. Elected President for at least **2** terms consecutively
 - b. Appointed Salon Chairman for at least **2** terms consecutively
 - c. Achieved outstanding recognition of exceptional services to SPP for at least **4** years consecutively
 - d. Actively contributing to the promotion of photography and is internationally recognised and accepted.
- iii. **HON. ESPP** – The Honorary Exhibitor (Hon. ESPP) is open to successful participants who have a total of **NINE (9)** entries accepted for **THREE (3)** consecutive Salons in the same section organized by the Society.
- iv. A candidate shall be proposed by at least **Two (2)** Council Members of SPP and endorsed by 'Honour Awards Committee' and must be approved by the SPP Council.

4. HONOUR AWARDS COMMITTEE

This committee shall comprise of at least **THREE (3)** members appointed by the SPP Council.

5. APPLICATION FROM ALLIANCE CLUB/SOCIETY

Application from members of Alliance Club/Society for any of the above awards, shall be based on mutual agreement between the Club/Society concerned and the SPP.
